## **WELCOME TO THE PLANNING ADVISORY COMMITTEE**

The cities of Phoenix and Tempe as well as their consultant, Coffman Associates, are pleased to welcome you to membership on the Planning Advisory Committee. We very much appreciate the interest you have in the F.A.R. Part 150 Noise Compatibility Study for Sky Harbor International Airport. We believe that, over the next year, you will be able to make an important contribution to the study and that you, in turn, will find your participation with the committee to be an interesting and rewarding experience.

## **WHAT IS THE ROLE OF THE COMMITTEE?**

The Planning Advisory Committee will play an important role in the course of the Noise Compatibility Study. We want to benefit from your unique viewpoints,

to have access to the people and resources you represent, to work with you in a creative atmosphere, and to gain your support in achieving results. Specifically, your role in the Planning Advisory Committee is as follows:

- **Sounding Board** - the Study Team needs a forum in which to present information, findings, ideas and recommendations during the course of the study. Every member of the study team will benefit from this forum because it allows diverse interests an opportunity to experience the viewpoints, ideas and concerns of other members directly.
- **Linkage to the Community** - each of you represents one or more constituent interests--neighborhood residents, public agencies, and aviation users. As a committee member, you can bring together the Study Team and the people you represent, you can inform your

constituents about the study as it progresses, and you can bring into the committee the views of others. The Study Team will provide their presentation materials and data to PAC members who might wish to volunteer to make presentations to their own constituents. Call the consultants at any time for advice and assistance.

- **Resource** - a study such as this is very complex; it has an almost unlimited demand for data and other information, but we have to know that it exists and how to get it. Many of you have access to specialized information and can ensure that it is used in the study to its fullest potential.
- **Think Tank** - "too many cooks spoil the broth" might reflect the difficulty that committees usually have in writing a report. On the other hand, "two heads are better than one" probably tells us that creative thinking is usually best accomplished by a group of concerned people who represent a diversity of backgrounds and views on a subject. We need all of the creative input that we can get. PAC member ideas have literally "made the difference" on other studies of this type across the U.S.
- **Direct Involvement** - an option, to be sure. If you have some ideas you want to explore in depth, we will provide the necessary back up. Discuss them with our staff. We will attempt to provide technical help, supplies, equipment, and reference materials. We don't want good ideas to be lost for lack of resources. - **Critical Review** - the study team needs their work scrutinized closely for accuracy, completeness of detail, clarity of thought, and intellectual

honesty. We want you to point out any shortcomings in our work and to help us improve on it.

- **Implementation** - each of you has a unique role to play in implementing the plan. The role you all have in common is to provide support for the final plan, after a consensus is reached, and leadership among your constituent interests. Inform and educate them about the importance of your effort on their behalf and work with them to see that the plan is carried out.

#### WHO IS ON THE COMMITTEE?

Many organizations have been contacted and invited to designate a representative to serve on the Planning Advisory Committee. We should know exactly who each of those individuals are by our first PAC meeting. The attached list of organizations invited shows a very broad range of interests to be represented--pilots, commerce, community, environmental, air traffic controllers, government and planning, as well as interested and affected citizens. Additionally, the full resources of the professionals from the airport staff, as well as the FAA, will be made available to the committee.

#### HOW WILL THE PAC OPERATE?

The Planning Advisory Committee will operate as informally as possible -- no rules, no compulsory attendance, no voting and no offices. The meetings will be conducted by the Study Team and will be called at various points in the study (approximately five) when there is a working paper to be discussed or when committee input is especially needed. Ordinarily, meetings will be scheduled with sufficient advance notice to permit you to arrange your own schedule. We will initially schedule

meetings in the afternoon and will continue to do so if the time is generally acceptable.

Normally, there will be an evening public workshop following the PAC meetings so that the Study Team may present reports to the community at large and elicit their views and input. We strongly urge you to represent the PAC at the evening workshops, particularly since many of the people you represent will be there.

In addition, the consultants and other volunteer study team members will make themselves available for small group meetings at private homes, neighborhood meetings, user group meetings, etc., periodically throughout the study period. We hope that some of the PAC members will arrange, or even host, such meetings.

To help you do your job, we will provide you with everything you will need. You will be on our general mailing list for the meeting notices and other communications and we will give you whatever assistance you might need to develop any ideas you would like to bring before the committee. Finally, you will each be provided with a Study Workbook (a three-ring binder with a

special cover) to hold working papers, PAC membership lists, meeting notices, and other resource material. The working papers are draft chapters of the Noise Compatibility Study report which will usually be provided to you well in advance of meetings. We will also provide an outline of the subjects to be covered in the next phase of the work efforts, so that you may interject your ideas and concerns and have them specifically addressed in the next working paper. Final copies of all reports will also be provided to each committee member at the end of the study.

### **SEE YOU AT THE MEETINGS !!!**

Once again, welcome to the Planning Advisory Committee and thanks for accepting the invitation to participate. We will do everything we can to make sure your participation is worthwhile, interesting, and a satisfying experience. We can all be rewarded by achieving an implementable program that reduces the present and potential impacts associated with aircraft noise. All users and neighbors of Sky Harbor International Airport will be better served as a result of these efforts.
