Chairperson Keogh Parks called the meeting to order at 3:01 p.m.

SUMMARY OF CURRENT EVENTS

1. Summary of Current Events from the Director of Aviation Services

Chad Makovsky, Aviation Director Services, updated the board on current events at the airport. Passenger numbers in March have increased from last year but are still down from 2019. Sky Harbor had a strong month in April. In May, passenger numbers may be close to 80% of 2019 numbers.

Mr. Makovsky shared that Sky Harbor is working closely with airline and concession partners to ensure that services are established for incoming passengers. The airport is seeing some strain with the Rental Car Center with the increase in passengers as the rental car businesses are working to meet demand nationally.

Mr. Makovsky shared air service updates stating that Frontier has added flights to Atlanta and Burbank. Hawaiian Airlines has added flights to Maui starting in May extending to August. Southwest has added flights to Honolulu, Oahu, and Maui. Sun Country Airlines has also announced routes to Wisconsin and Minnesota.

Mr. Makovsky informed that the Terminal 2 mural has been removed from the terminal and is in its storage facility awaiting final placement in the Rental Car Center in July.

Mr. Makovsky stated the airport is still requiring facial coverings and must follow federal guidelines. In April the airport vaccinated over one thousand employees and family members. The second series of shots are happening today.

Mr. Makovsky shared that City Council has recently approved: Aviation Department Environmental On-Call Consulting Services contract, Billboard Outdoor Advertising, and Parking Management MFP Award.

Chairperson Keogh Parks asked all attendees in person at the PAAB meeting to wear masks during the meeting.

2. Summary of Current Events by the Airline Station Manager

Mr. Camilo Henao, Airline Station Manager, stated that he has seen an increase in bookings. He shared that Delta will be adding eight additional departures during the summer. Frontier has added two new routes. Frontier decided to pull out of LAX and will continue to Ontario and other LA area airports.

DISCUSSION AND POSSIBLE ACTION (ITEM 7-8)

7. Distributed Antenna System

Daver Malik, Assistant Chief Information Officer spoke to the board about the Distributed Antenna System (DAS). The DAS has been a long term need for the airport. Currently cell service at the airport is limited and service can be inconsistent. Passengers and employees rely on their devices to access mobile data and view media. 4G is currently being upgraded to the new 5G and it will carry over 50% of global data for mobiles. 5G has a hard time going through buildings and if the airport continues to rely on towers outside of the airport the service within the airport will decline significantly. To remedy this a dedicated infrastructure within the airport is needed. The DAS will ensure coverage throughout the airport, capacity to serve all passengers, guests, and employees at the airport, and provide the bandwidth that is needed to support these devices.

Mr. Malik stated the RCS was sent out in December. The provider will need to support all cellular providers, be licensed, and provide 5G. It is an expected to go live on Jan. 1, 2023. The coverage area includes all public access areas and nonpublic areas like administrative offices, baggage handling, and airside areas. The RCS received five responses in March, three were deemed responsive. Evaluation was based on method of approach, revenue plan, qualifications and experience, and business plan. Based on the results it is recommended that AT&T be awarded the contract. The contract is ten years with two, one-year extension option.

Mr. Aldieri asked if coverage will include the Sky Train. Mr. Malik answered that all the Sky Train stations are included as well as the Rental Car Center station.

Mr. Aldieri asked if parking wait areas are also included. Mr. Malik responded yes.

Ms. Fisker asked about AT&T's qualifications. Mr. Malik was unsure about other airport locations but stated the team did review qualifications in the evaluation.

Mr. Foster who would own the equipment at the end of the lease term. Mr. Malik answered that the City will take ownership.

Mr. Cohn asked if there is a provision that requires the provider to remove equipment at the end of the contract as in ten years there will most likely be a need for an upgrade. Mr. Malik answered that yes, it is a standard provision that the incumbent will take out the infrastructure if the airport chooses not to improve.

8. Request to Award Aviation Luggage Cart Service Revenue Contract Solicitation

Mr. Michael O'Shaughnessy, Deputy Aviation Director, presented the request to award aviation luggage cart service revenue contract. The incumbent is SmarteCart, LLC and the current contract costs the airport \$405k. The airport currently pays for cart service and is hoping to move this to a revenue earning contract. The new contract term is five years with no options to extend. The airport will receive 8% of the revenue derived from monthly sales. In 2018 the luggage carts generated \$584k,

2019 generated \$542k, and in 2020 generated \$291k. The current rate to rent a cart is \$5 and that rate will be maintained. International travelers coming from Customs and Border checks will have access to the carts for free. Additionally, the Rental Car Center will have free carts until the PHX Sky Train is complete. At \$1.25 per cart the airport will be paying an estimated cost of \$320k.

Mr. O'Shaughnessy stated the RCS was issued in February of 2021. Two proposals were received by SmarteCart and APS USA LLC. The evaluation committee deemed SmarteCart unresponsive as they did not address concerns within the RCS. The evaluation criteria included qualifications, management plan, operation plan, and maintenance plan. Based on this criteria APS USA LLC is recommended to receive the contract. They are a global company based in Switzerland.

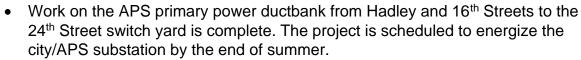
Fixed Facilities:

 Construction of the Rental Car Center and 24th Street stations is complete and the project has been turned over to the City and the system contractor for PHX

Sky Train system installation and testing.

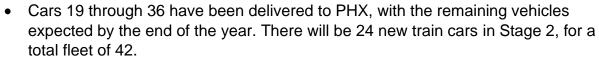
- Construction of the 24th Street Economy Parking Lot continues, with completion expected by the end of the year.
- The new I-10 on-ramp at the intersection of Buckeye Road and Copperhead is open to traffic; the related I-10 off-ramp





Train System:

- The train system contractor
 Alstom has completed the
 installation of the concrete
 running surface plinths, guide
 beam, power rail, mechanical
 switches and equipment along
 the Stage 2 guideway.
- Construction of the Maintenance and Storage Facility expansion was completed in May.
- Train vehicle manufacturing is also underway with 6 vehicles in varying stages of assembly in Pittsburgh, PA.



• System testing began last month, and will continue through next summer, when the Stage 2 expansion is expected to open for passenger service.



Terminal 4 S1 Concourse Project

- The FAA Apron Grant was awarded last spring and construction is underway with completion anticipated in early 2022.
- McCarthy Construction continues with sitework, including utilities, concrete structural columns, and retaining wall construction.
- The existing Terminal 4 S2 Concourse basement is being renovated to house baggage handling systems (BHS) to
 - support the new concourse. Modifications are complete and the BHS conveyor system has been installed. Initial operation and testing of the system is underway.
- The new Terminal 4 Level 1 inbound bag claim carousel 8 is complete and operational.
- The North/South connector bridge construction continues with completion anticipated this fall. Terrazzo floor installation continues, as well as modifications to accommodate the new consolidated checkpoint exit.
- Security Checkpoint A and D modifications are underway with completion scheduled for spring of 2022.

Terminal 2 Demo Project

- The Terminal 2 concourse building has been completely demolished with existing utility and fuel systems removed. The concrete apron pavement is also complete where the concourse was located.
- Design for Phase 2 of the project –
 demolition of the Processor and Garage
 is complete. Concrete paving is
 - underway where the processor was located along with other apron construction resulting from the facility demolition. Terminal 2 frontage and roadway modifications are complete allowing traffic to continue past Terminal 2, providing access to the remaining Terminal 2 Parking Garage. The garage will remain operational until a future date, depending on development plans for the west area of the airport.
- The mural relocation plan is complete with the mural temporarily removed and stored at on off-site location. Structural work is underway in the center core of the Rental Car Center to receive the mural this fall.

Report Summary

Bimbo currently leases 65,340 square feet of the property at the northeast corner of 3115 E. Madison Street, for parking its tractor trailer trucks. Tenant is requesting an additional 100,263 square feet of parking space and two one-year extension options be added to the contract.

Contract Term

The current contract term is three (3) years, expiring April 14, 2023. The term may be extended to April 14, 2025, if the two additional one-year extension options are exercised. The contract also has a sixty-day cancellation notice by either party.

Financial Impact

Rent will be approximately \$14,381.36 per month. Total anticipated rent over the initial term will be approximately \$461,509. Rent will be adjusted annually based on the Consumer Price Index for Phoenix-Mesa-Scottsdale or three (3) percent, whichever is greater.

Report Summary

Due to COVID-19, various aspects of aircraft operations (eg, flight schedules and frequency) quickly changed creating temporary or perceived community impacts. Additionally, the Federal Aviation Administration (FAA) is involved in various lawsuits both locally (Scottsdale vs. FAA) and outside of Arizona that may directly or indirectly impact FAA airspace management in our region. Finally, several federal policy matters (eg, FAA Noise Annoyance Surveys) are being monitored for potential impact to the City airport system. This report will review these topics in technical detail.

Location

Report Summary

CAMP, the master plan for Phoenix Sky Harbor International Airport, was adopted by City Council over two years ago. Since then, significant progress has been made towards regulatory approvals, grants, programming, and negotiations with strategic stakeholders such as Union Pacific Railroad, Honeywell, and Air National Guard. Unforeseen events such as COVID-19 have affected various aspects of both aero- and non-aeronautical demand. This report provides an update of the Aviation Department's recent revenue, enplanements, and business activity to the Phoenix Aviation Advisory Board.

Report Summary

The City of Phoenix has owned and operated the city's airport system as a self-supporting enterprise since 1967. Through the Aviation Department, the city manages several lines of airport business, associated revenues, expenses, and maintains credit to support financing the capital investments of a large-hub commercial airport.

Impacts of the COVID-19 pandemic on Sky Harbor Airport and the larger aviation industry have been significant. The reduction of 41% of the airport's passengers over the past fiscal year has presented a significant challenge to the enterprise model as the airport must continue to maintain net revenues sufficient to support its operations, make debt service payments, and preserve cash reserves.

Although passenger traffic has rapidly returned to 2019 levels over the past 4 months, recent increases in COVID-19 cases combined with labor shortages throughout the airport have presented new challenges and a need to continue to plan strategically for what may be a protracted recovery.

Staff will present an overview of Sky Harbor's recent enplanement results, business activity, and an update on the Aviation Department's financial position.
