2025 Year in Review

FAA Modernization Project
The FAA will be preparing an Environmental Assessment for the Phoenix Area FAA Modernization Project to determine potential environmental impacts. The Phoenix Area FAA Modernization Project is a proposal to implement new satellite-based air traffic procedures and make updates to the existing satellite-based air traffic procedures that will help enhance safety and improve air traffic efficiency at airports within the region, including PHX, DVT, and GYR. The FAA will be seeking stakeholder input on these changes and anticipates holding public engagement workshops in late Spring 2026. FAA Flight School Policy Public Engagement
The FAA is updating various rules and policies related to pilot schools. Noise Monitor Terminal (NMT) Maintenance
Three NMTs are experiencing long-term outages. At NMT-04 and NMT-16, faulty proprietary power boards are set to be replaced in early 2026; At NMT-06, continued vandalism has resulted in staff looking for more secure, nearby locations.

Ideagen Acquisition
In 2025, Ideagen acquired Casper BV, the current noise monitoring and flight-tracking system provider. Casper will continue to provide technical support for the City.

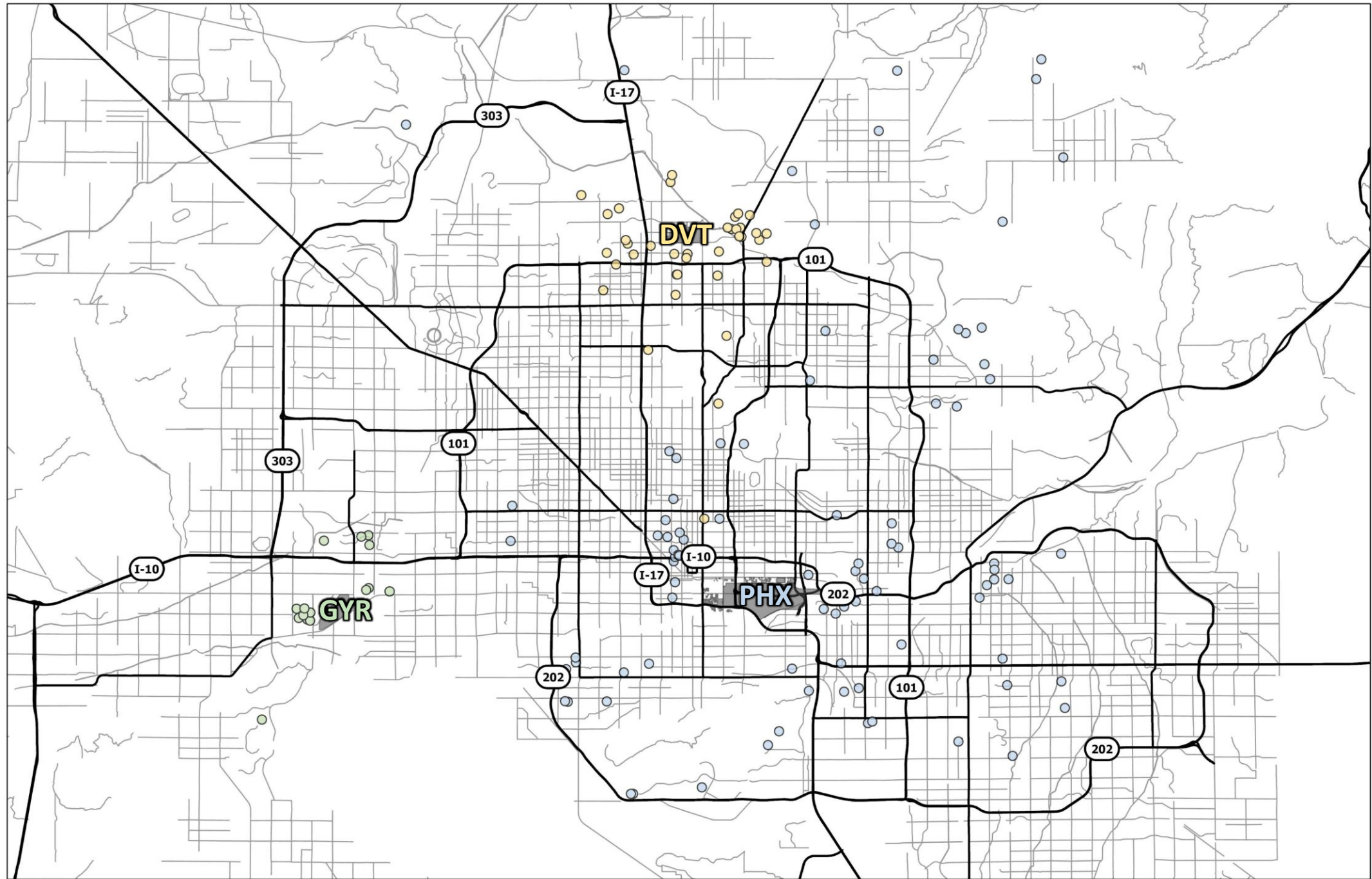

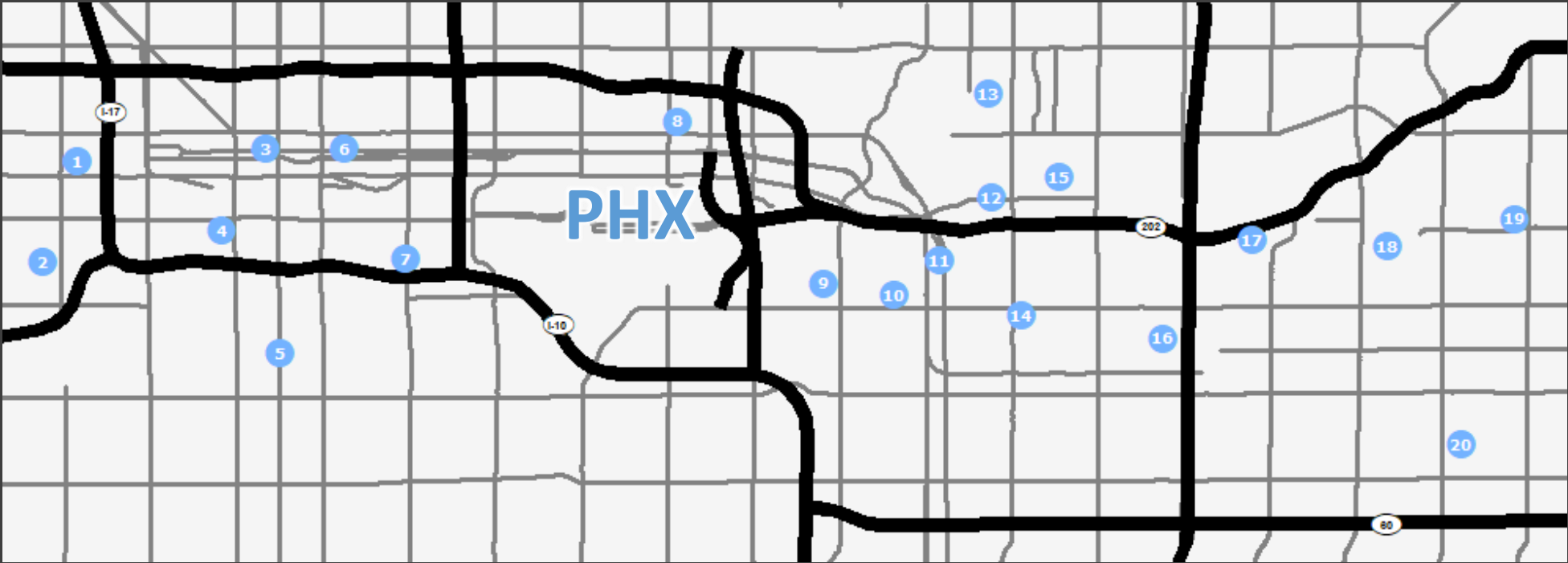
Map of 2025 Complainant Households

Sky Harbor Noise Abatement Performance

Departure Corridor Equalization

To minimize community impacts from overflight, Phoenix works with the FAA to ensure departures from Sky Harbor are balanced in terms of east and west flows over the calendar year.

Departure Gate Compliance

To minimize community impacts from overflight, Phoenix works with the FAA to ensure departures from Sky Harbor do not turn out of the Salt River compatibility corridor earlier than necessary. In east flow operations, the turn “gate” aligns with the Loop 101 freeway. In west flow operations, the turn “gate” aligns with 43rd Avenue. The compliance percentage measures the relative number of jet aircraft departures that did not turn before the gate (i.e., remained inside the compatibility corridor).
