Table 1 – Acceptable Documents for Foreign-Born Non-US Citizens

Provide One Item From Column A

- Permanent Resident Card or Alien Registration Receipt Card with photograph (Form I-551)
- Unexpired foreign passport, with a temporary I-551 stamp
- Unexpired Employment Authorization document that contains a photograph (Form I-766, I-688, I-688A, or I-688B)
- An unexpired foreign passport with an unexpired arrival/ departure record, Form I-94, bearing the same name as the passport and containing an endorsement of the alien's non immigrant status, if that status authorizes the alien to work for the employee
- Form I-94 issued to a refugee initially arriving in the United States. The document must be stamped with a legend showing that the individual has been admitted as a refugee. The form expires one year from issue date.

- Driver's license or ID card issued by a State or outlying possession of the United States provided it contains a photograph or information such as name, date of birth, gender, height, eye color, and address

- Certificate of Naturalization, Form N-550 or N-570
- Certificate of U.S. Citizenship, Form N-560 or N-561

- Original or certified copy of a birth certificate issued by a state, county, municipal authority, or outlying possession of the United States bearing an official seal
- Native American tribal document
