2022 Year in Review

Performance Indicators

In 2022, operations levels at PHX increased from 2021 by 2.6%, DVT operations increased by 1% and GYR operations increased by 74%. Total households submitting complaints decreased at PHX and DVT but increased at GYR. PHX departure gate compliance remained at 99% and departure direction equalization splits were also in-line with previous years.

Tempe Entertainment District

Staff took an active role by engaging in discussions with the potential developer and the City of Tempe over a large site just 10,000' east of PHX where a redevelopment project including housing was proposed; the site is within the current 65 DNL contour. Through negotiations, a variety of noise mitigation requirements were agreed to by Tempe.

FAA PBN Working Group

In Spring 2022, FAA kicked off a Performance Based Navigation Working Group to address efficiency and safety improvements in our region's terminal and en route airspace. Conceptual changes and public outreach are expected to occur in 2023.

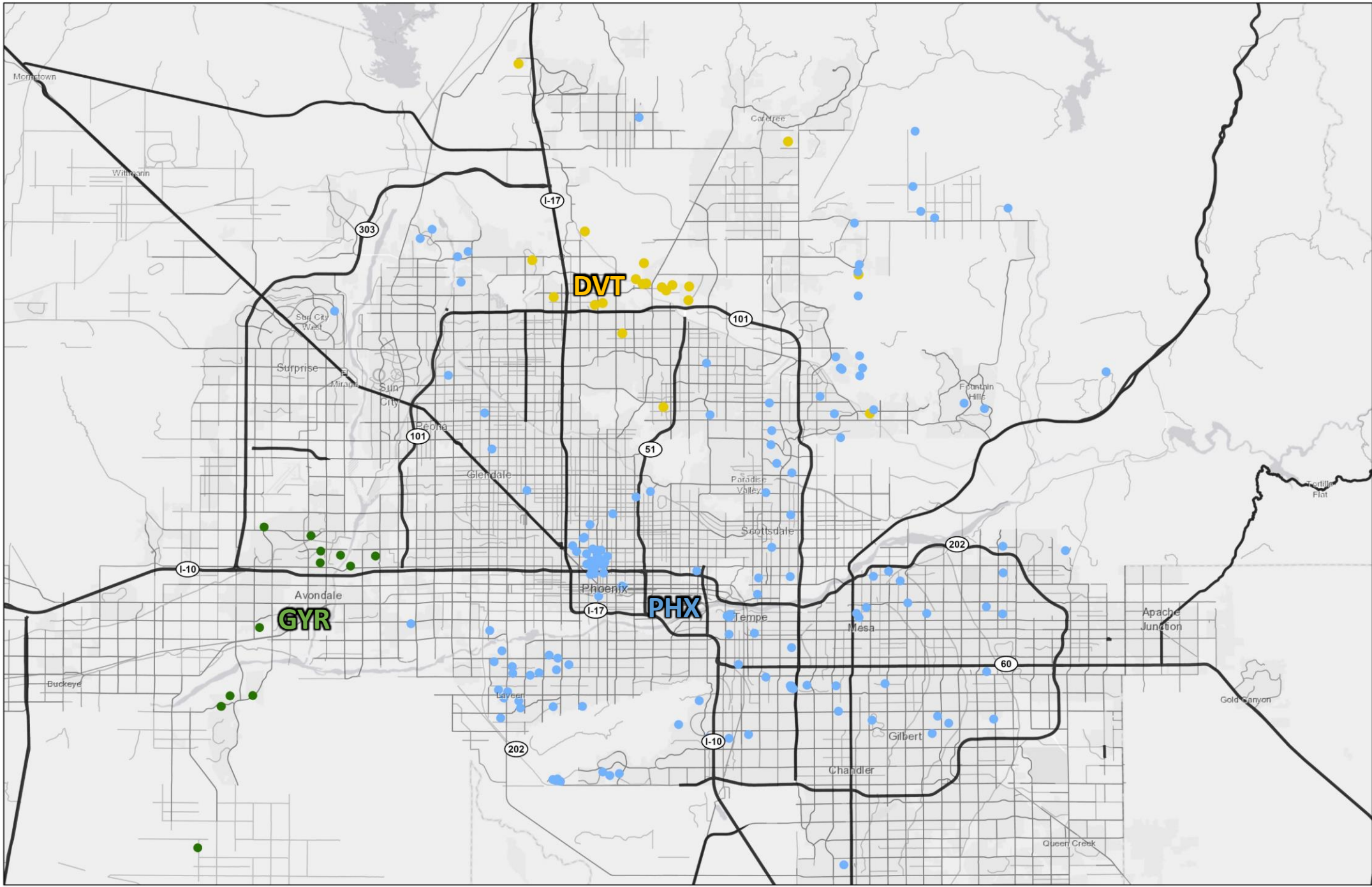

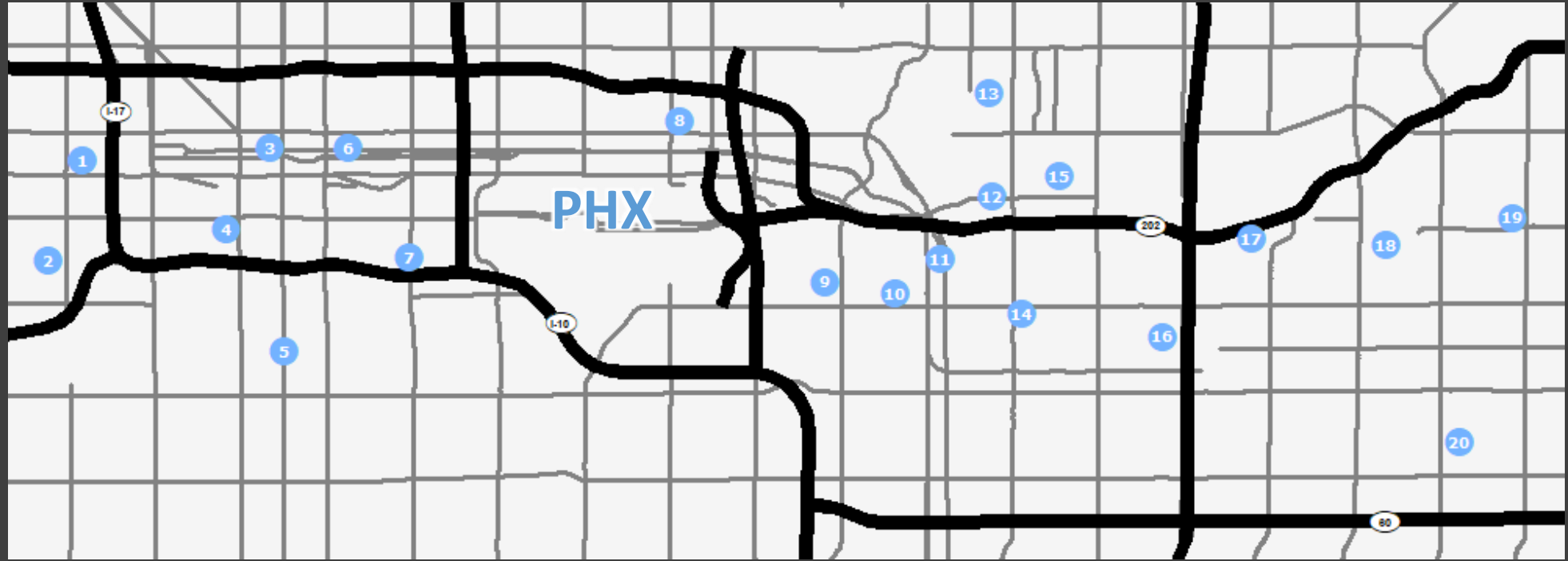
Map of 2022 Complainant Households

Departure Corridor Equalization

To minimize community impacts from overflight, Phoenix works with the FAA to ensure departures from Sky Harbor are balanced in terms of east and west flows over the calendar year.

Departure Gate Compliance

To minimize community impacts from overflight, Phoenix works with the FAA to ensure departures from Sky Harbor do not turn out of the Salt River compatibility corridor earlier than necessary. In east flow operations, the turn “gate” aligns with the Loop 101 freeway. In west flow operations, the turn “gate” aligns with 43rd Avenue. The compliance percentage measures the relative number of jet aircraft departures that did not turn before the gate (i.e., remained inside the compatibility corridor).
