

## PHX GT Authorized Signer Training

I am aware and agree to comply and inform employees (drivers) of the following:

\_\_\_\_\_ All company drivers and authorized signers must provide proof of a cleared and completed background check.

\_\_\_\_\_ If a driver or vehicle is discontinuing service with your company, the mentioned items listed below, you will need to return the items to the GT office as they are City of Phoenix property. Authorized Signers are responsible for the monitoring and returning of issued placards, decals, AVI stickers, or bumper tags.

\_\_\_\_\_ All company changes (name, address, phone, email, etc.), must be performed/relayed with the GT office.

\_\_\_\_\_ Authorized Signers filling out the GT (placard) application must make sure the form is filled out entirely by the driver and the Signer. If the application is incomplete (or signed over 30 days before submittal), the GT application will be confiscated and shredded. The Authorized Signer will have to reissue the GT application.

\_\_\_\_\_ Authorized Signers and their employees (drivers) are responsible for bringing the vehicle to Ground Transportation immediately when the car has a windshield replacement so that Ground Transportation may replace the AVI transponder and Decal. (The AVI becomes defective upon removal. This is a violation you will be subject to a 50-point Notice of Violation-NOV which can be a 30-day suspension).

\_\_\_\_\_ Non-TNC operators that have an AVI transponder may not stage in any of the GEO fencing areas such as 44<sup>th</sup> street; if you do, you will accrue a trip fee. Protesting this fee will not be allowed.

\_\_\_\_\_ Authorized Signers and their drivers are responsible for renewing and/or replacing expired or worn decals and AVI transponders (windshield replacement, weather worn, etc.).

\_\_\_\_\_ When a driver loses their placard (ID), Authorized Signers will need to provide a letter indicating the driver has lost their driver's ID, and a new GT driver application is required.

\_\_\_\_\_ Authorized Signers must immediately notify Ground Transportation when a driver, authorized signer/DLPC, no longer works for the company.

\_\_\_\_\_ All company employees understand and will comply with the Americans with Disability Act (ADA) requirements as outlined in the PCC Chapter 4, and Rules & Regulations 08-01.

\_\_\_\_\_ Drivers are not to stage at the curbs; it is a "Load and Go" zone only. Customers should be at the curb ready for pick-up. Hold lots are on East and West end of the airport.

\_\_\_\_\_ Authorized Signers are responsible to check the **vendor portal** to ensure Trip Fees are accurate.

\_\_\_\_\_ Accounts with a past due balance will need to bring the account current immediately, or agree to a 90-day payment plan, or GT will not provide the following services, and your company will be suspended:

- ✓ Completing, Renewing a new 2-year Permit Application
- ✓ Transferring a vehicle to/from another company, or adding a new vehicle to the fleet
- ✓ Renewing, or replacing a lost, damaged decal
- ✓ Requesting a temporary permit
- ✓ Other company/vehicle services as determined

\_\_\_\_\_ Valid Commercial Insurance is required. We do not accept rideshare or personal policies; all vehicles must have "Commercial Livery" coverage.

\_\_\_\_\_ Authorized Signers must ensure each vehicle registered with Ground Transportation carries an attestation form if the vehicle was manufactured within 10 years from the current year, any vehicle older than 10 years must carry a 19-point inspection.

\_\_\_\_\_ Authorized Signer understands that failure to abide by the above rules can result in the issuance of a Notice of Violation (NOV), and your company may be subject to suspension/revocation from operating at Sky Harbor Airport.

\_\_\_\_\_ Authorized Signer understands that all statements, information, and documentation provided by applicant are true and complete and that any falsification or material omission will void the permit.

\_\_\_\_\_ Authorized Signer understands that Arizona Revised Statute § 13-2311 makes it a class 5 felony to make or use any false document knowing that the document contains any false or fraudulent statement in any matter related to business conducted by the City of Phoenix Aviation Department.

\_\_\_\_\_ All Drivers (except CDL Charter drivers) need to possess a valid AZ driver's license.

\_\_\_\_\_ A/S is responsible for all drivers on their account, which includes leased vehicles.

\_\_\_\_\_ A/S must return the AVI Tag and decals for temporary vehicles when they return it.
